Trina Liang, President of Netball Singapore, welcomed the AGM attendees and expressed her appreciation for their attendance and support. Daniel Ho, CEO of Netball Singapore, provided a summary of Netball Singapore's key priorities and activities for the year.



2	Agenda Item 1: To receive and approve the Annual Report of the Association for the year 2024/25 The Netball Singapore Annual Report 2024/25, which was circulated to Members on 3 September 2025, was taken as read. Members unanimously approved the Annual Report.
3	Agenda Item 2: To receive and approve the Financial Accounts of the Association for the year ended 31 March 2025 Soh Kok Leong, Treasurer of Netball Singapore, shared brief remarks on Netball Singapore's healthy financial situation and its prudent approach to finances. Members unanimously approved the Financial Accounts.
4	Agenda Item 3: To appoint the Auditor for the new financial year 2025/26 Daniel introduced S B Tan Audit PAC (represented by Yong Seet Lee) and expressed Netball Singapore's intention to reappoint the firm as the Auditor for the new financial year 2025/26. S B Tan Audit PAC likewise expressed its willingness. Members unanimously approved the appointment of S B Tan Audit PAC as the Auditor for the new financial year.
5	Agenda Item 4: To elect 6 board members for a 4-year term to 2029 As of the closing deadline of 3 September 2025, 6 nominations for the 6 positions were received and verified to be valid. • Soh Kok Leong • James Walton • Sharmaine Chan • Micky Lin Qingyi • Ng Boon Heong • Azriman Mansor As there were no contesting/opposing candidates, all 6 nominees were elected to the Netball Singapore board for a 4-year term to 2029.



6	Agenda Item 5: To transact any other business Admiralty CSN tabled a special resolution to be inducted as a Full Member of Netball Singapore. Members unanimously voted in favour of the special resolution, and Admiralty CSN was duly inducted as a Full Member.
